#### **DOG COMPLAINTS**

We all love our furry friends and the joy they bring. However, there has been an uptick in complaints to the Grovewood Board of multiple dogs in the neighborhood whom are unleashed and even unattended wandering the property. This has caused uncomfortable situations for some who may be walking their dogs on a leash. We want to ensure Grovewood stays a safe place to live. We ask that owners ensure their dogs are on a leash when outside their home or safely within a fenced in yard. While there is no deed restriction to enforce behavior of dogs, there are city codes which control animals. We have instructed some owners if they have further concerns, to report it to the City. City code empowers police officers to handle all animal complaints, including barking dogs, animals running at large, etc. To report a violation involving animals, please call the Clearwater Police Department at 727-562-4242.

# REPORT ALL CRACKED SIDEWALKS....AGAIN

It has been over 2 months since the City of Clearwater came out and marked the areas of our sidewalks and gutters that need to be repaired or replaced. We have seen very little action. If you still have sidewalks that need to be fixed, keep calling the City requesting this service. We have many areas that are safety hazards for people walking the sidewalks of our neighborhood. We also have some cracked curbs and gutters and areas on the roads where water collects when it rains. These areas become a breeding ground for mosquitoes so they should also be reported.

Let the City know if you have poor drainage problems on the road in front of your home and they will be able to address that problem at the same time that they repair the sidewalks. The City requires that individual homeowners contact them with their problems. We cannot request them to come out to our neighborhood to look for areas that need to be fixed. We need you to call them and report your specific address and problem.

Please call the City of Clearwater at 727-562-4950 to report the locations that should be inspected and considered for repair.

# **ARCHITECTURAL REVIEW GUIDELINES**

Grovewood is a Deed Restricted Community. The Board of Directors have the responsibility of making sure the deed restrictions are followed. It is not the intent of the Board to prevent you from making improvements to your property. We hope you will continue to improve your property which increases your property value and the value of your neighbor's property as long as the improvements conform to the Deed Restrictions and add value. It is important to remember you must send your plans to the Board for review before you get your permits and start work. The Board of Directors adopted Architectural Review Guidelines on 9/18/2018. The Guidelines will be sent to you soon and a few copies will be available at the Annual Meeting on November 13<sup>th</sup>. You can review the Deed Restrictions and Guidelines on our web site <a href="www.grovewoodhomeowners.org">www.grovewoodhomeowners.org</a>. Be sure to review the Deed Restrictions and Guidelines so you will be informed. When you submit your plans to the Board, we will review your request in a timely manner. This email address only goes to the Board of Directors, not to all of the neighborhood email addresses.

It makes it too easy for these bad folks to get in your car and take anything they can use later on such as credit cards or your IDs. Some of our neighbors still keep their garage doors open during the day when they are inside. Again, that makes it so easy for these people to take things from your home during the day when most home burglaries occur. The Clearwater Police Department's non-emergency number is 727-562-4242. Call them when you see anything that does not seem right or normal. They will come out to investigate.
